SECTION-II

PREFACE

INTRODUCTION:

REC Power Distribution Company Limited (RECPDCL) is a wholly owned subsidiary of Rural Electrification Corporation Ltd (REC), a "Navratna CPSE" under the Ministry of Power, Govt. of India.

RECPDCL is engaged in providing value added consultancy services in power sector arena covering Power Generation, Transmission & Distribution (T&D), Renewable Energy Sector and Energy Efficiency programs including Govt. of India's schemes for power utilities across the country and various regulatory assignments with CERC/SERCs. It includes the project works under Rural Electrification, urban electrification, PMC works, DPR preparations under various schemes of Govt. of India, and other power project schemes, Third Party Inspections, Feeder Renovation Programme, Feeder Separation, HVDS Programme, Lender's Engineers Assignment, IT related assignments in Distribution sector including Energy Audit, Evaluation study for HVDS/Distribution network, AT&C Loss assessment, System study, MRI based billing and Cost Book Data Preparation as per the need of the power utilities, State/Central Electricity Regulatory Commission across the country.

SECTION-III

INTENT AND OBJECTIVES

RECPDCL is inviting Expression of Interest (EOI) along with the information as required for the detailed evaluation from the prospective agencies who can participate in this empanelment process as per the eligibility criteria and terms & conditions mentioned in this EOI.

RECPDCL encourages participation of the agencies which are technically and professionally qualified in the sector of LED Lighting Based Energy Efficiency Projects with experienced personnel and resources to provide the services required by the RECPDCL in timely and efficient manner.

The objective of this empanelment will be broadly to work in the area of LED based "Solar" or "without solar/grid connected" lighting systems, including design, supply, erection/installation/retrofitting in place of conventional lights, testing, commissioning, operation and maintenance in different application areas such as street lights, Buildings, houses etc. in different towns, cities, villages including remote villages in hilly, desert and forest areas across the country. However, the detailed scope of work will be finalized on case to case basis by RECPDCL at its sole discretion while seeking financial quote from the empanelled agencies.

Agencies will be empanelled for said area of work as per eligibility criteria as detailed in Section-IV.

LED Lighting Projects of similar nature means: Design, supply, erection/installation/retrofitting in place of conventional lights, testing, commissioning and/or operation and maintenance of LED based "Solar" or "Without Solar/Grid Connected" lighting systems in different areas of applications such as Street Lights in Municipal/ Civic areas, Commercial Buildings, Offices, Institutions or any other area for any Central Government/ State Government/ Semi-Government Organization/ Public Sector Undertaking (PSU) in India.

It is to be noted that the only "supply of LED based lights, fixtures/modules and other accessories" shall not be considered for evaluation under project completion criteria.

General Conditions for Consortium/Joint Venture Firms:

- Member of any Consortium/Joint Venture Firm shall not be permitted to participate either in individual capacity or as a member of any other Consortium/Joint Venture Firm in the same tender. Submission or participation in more than one bid will cause disqualification of all the proposals submitted by the bidder. Number of members in a Consortium/ Joint Venture Firm shall not be more than TWO.
- 2. In case of Consortium/Joint Venture Firm, 'Lead Member' should be the agency which has successfully executed similar LED lighting project(s) in India for any Central/ State Government/ Semi-Government Organization/ Public Sector Undertaking (PSU) in last 07 years having project cost as detailed in Table-1 above in respect of Categories i.e. A, B & C for which EOI response is submitted whereas other partner in Consortium/JV should be a domestic manufacturer of LED based lights for past three years. However, if manufacturer itself intends to execute the LED lighting projects, it can also act as a 'Lead Member' subject to qualifying the above criteria.
- 3. All formalities in respect of submission of tender shall be done only in the name of 'Lead Member' and not in the name of Consortium/Joint Venture Firm. However, name & other details of both the members of Consortium/ Joint Venture Firm should be clearly mentioned in the Bid/Response.
- 4. A copy of Memorandum of Understanding (MOU) executed between the members of Consortium/JV shall be submitted along with the tender. The complete details of the members of the Consortium/Joint Venture Firm, their share and responsibility in the Consortium/JV etc. particularly with reference to financial, technical and other obligations shall be furnished in the MOU.
- 5. Once the EOI response is submitted, the MOU shall not be modified / altered/ terminated during the period of empanelment with RECPDCL including any extension thereafter by RECPDCL or validity of any work order awarded to the said Consortium/Joint Venture Firm. In case, the tenderer fails to observe/comply with this stipulation, the full Security Deposit/ Earnest Money Deposit (EMD)/ Performance Bank Guarantee (PBG) shall be liable to be forfeited.
- 6. A duly notarized agreement of Consortium/Joint Venture Firm shall be executed between the 'Lead Member' and Consortium/JV Partner as per prescribed format given in Annexure-VIII. This Agreement should be submitted in original with EOI response.

- 7. Authorized Member of Consortium/Joint Venture Firm: 'Lead Member' shall be authorized on behalf of Consortium/Joint Venture Firm to deal with the tender/RECPDCL, sign the agreement or enter into contract in respect of the said tender, to receive payment and such activities in respect of the said tender/ contract. All notices/ correspondences with respect to the contract would be sent only to this 'Lead Member' of Consortium/Joint Venture Firm.
- 8. Required processing fee shall be submitted either by the 'Lead Member' or by the 'Joint Venture/Consortium Firm' itself. In case of submission of processing fee by the 'Lead Member', a duly signed confirmation shall be furnished as per **Annexure-VI** to the effect that processing fee submitted by 'Lead Member' should be deemed as processing fee submitted by the Consortium/Joint Venture Firm.
- 9. Duration of MOU and Consortium/JV Agreement shall be valid during the entire Empanelment period and any extension thereafter /currency of the contract including the period of extension, if any
- 10. Any change in constitution of Consortium/Joint Venture Firm shall not be allowed.
- 11. On award of any contract to the Consortium/ Joint Venture Firm, a single Performance Bank Guarantee shall be submitted by the Consortium/ Joint venture Firm as per tender conditions. All the Guarantees like Security Deposit, Earnest money Deposit, Performance Guarantee, Bank Guarantee for Mobilization Advance etc. shall be accepted either only in the name of 'Lead Member' or in the name of 'Joint Venture/Consortium Firm' and no splitting of guarantees among the members of Consortium/JV shall be permitted.
- 12. Members of the Consortium/Joint Venture Firm shall be jointly and severally liable to the RECPDCL for execution of the project/ Work/ Assignment etc. The Consortium/JV members shall also be liable jointly and severally for the loss, damages caused to the RECPDCL during the course of execution of any awarded contract or due to non-execution of the contract or part thereof.
- 13. **Governing Laws for Consortium/ Joint Venture Firm:** The Consortium/JV Agreement shall in all respect be governed by and interpreted in accordance with Indian Laws.

SECTION-VI

SCOPE OF WORK

Scope of work for empanelled agencies may be as below:

1. Empanelled agencies **broadly** would be required **but not limited** to following:

To work in the area of LED based "Solar" or "without solar/grid connected" lighting systems, including design, supply, erection/installation/retrofitting in place of conventional lights, testing, commissioning, operation and maintenance in different application areas such as street lights, Buildings, houses etc. in different towns, cities, villages including remote villages in hilly, desert and forest areas across the country. However, the detailed scope of work will be finalized on case to case basis by RECPDCL at its sole discretion while seeking financial quote from the empanelled agencies.

Note: LED based lights, fixtures/modules and other accessories supplied by the agency shall conform to latest Indian/International Standards as applicable.

Further, scope of work may also include following:

- 2. Retrofitting of LED based lights may also include the dismantling, handling and/or buyback the existing conventional lights & fixtures.
- 3. Supplier may also be required to provide comprehensive on-site warranty (for a definite time period i.e. 2-8 years etc.) for all retrofitted LED luminaries. Period of warranty will be fixed as per the requirement of the project and will be mentioned in the Notice Inviting Financial Bid.
- 4. Empanelled agencies may also be required to conduct the energy audit to assess the potential of energy savings in a specific project by deploying their BEE (Bureau of Energy Efficiency) certified Energy Auditor(s). A detailed report on energy savings will be required to be submitted by the agency based on the energy audit conducted.
- 5. Any empanelled agency, to which work is awarded later on, may have to conduct a detailed field survey before implementation of the project. Deliverables of detailed field survey shall be as below but not limited to:
 - A. Assessment of existing conventional lighting installations to compile type, wattage and number of luminaires of each type and wattage connected to each switching point along with identification of Switching Points and individual Poles. Type and height of the Poles should also be known to assess the requirement of appropriate ladder mounted vehicles.
 - B. Assessment of infrastructure components like bracket, arm, clamps, requirement of wire/cable for connection of LED luminaries up to power supply point or any other component required to integrate new LED luminaries into existing fixtures etc.

- C. To obtain the Area Street Maps and to mark the roads on which LED Street Lights are to be installed on the Area Street Maps.
- 7. Transportation of goods up to destination and storage of the same till installation at the desired location in such works shall be sole responsibility of the agency to which the work has been awarded. Goods shall be fully insured in Indian Rupees by the agency itself.
- 8. RECPDCL intends to execute LED lighting projects through any of the following mechanisms:
 - A. **ESCO Model:** RECPDCL would take up LED Lighting Based Energy Efficiency Projects which will be executed through ESCO (Energy Service Company) Model thereby facilitating 'No' or 'Minimum Upfront Cost' to the clients. Financial structure of this model may be as below:
 - Financing required for implementation of the project will be arranged completely by RECPDCL.

OR

II. Supplier would be required to arrange complete financing for the project.

OR

- III. Supplier would be required to share a part of the upfront cost and resulting profit from the project with RECPDCL. Ratio of share will be decided based on pre-evaluation of project through mutual agreement between supplier and RECPDCL. It may vary case to case.
- B. EPC/Turnkey Model: RECPDCL would also take up LED Lighting Projects based on EPC/Turnkey Model. In such cases, supplier would be required to design, supply & install/retrofit LED based lights. Payment terms for such projects will be defined clearly in the notice inviting financial bid. Selection of suitable agency for such projects will be based on limited tender among all empanelled agencies.

Note: RECPDCL reserves right to add/delete/modify the scope of work as per requirement of the project.

- 2. Each bidder should submit **ONLY SINGLE** bid/response as per fulfilling the eligibility criteria given in Section-IV.
- 3. RECPDCL reserves the right to verify/confirm all original documentary evidence submitted by the bidder in support of above mentioned clauses of eligibility criteria, failure to produce the same within the period as and when required and notified in writing by RECPDCL shall result in summary rejection of the bid.
- 4. The bidder shall ensure that deputed personnel are trained and experienced for jobs as defined in scope of work for ensuring the high quality and correctness of jobs so that job is carried out in a highly professional and sound managerial manner.
- 5. Empanelment shall be initially for a period of two years, which may further be renewed at the sole discretion of RECPDCL.
- 6. Empanelment with RECPDCL does not confer any right to the agencies to be invited for participating in any bids, tenders etc. floated by RECPDCL RECPDCL reserves the right to call bids/assign work/associate the agency/agencies in any area as may be deemed fit by RECPDCL depending upon the profile provided by the agencies and requirement of assignment.



Further, RECPDCL has sole discretion to extend or restart the auction event in case of any glitches in infrastructure observed which has restricted the bidders to submit the bids to ensure fair & transparent competitive bidding. In case an auction event is restarted, the best bid as already available in the system shall become the basis for determining start price of the new auction.
- 7. In case the bidder fails to participate in the auction event due any reason whatsoever, it shall be presumed that the bidder has no further discounts to offer and the initial bid as submitted by the bidder as a part of the tender shall be considered as the bidder's final no regret offer. Any offline price bids received from a bidder in lieu of non-participation in the auction event shall be out rightly rejected by RECPDCL.
- 8. The bidder shall be prepared with competitive price quotes on the day of the bidding event.
- 9. The prices as quoted by the bidder during the auction event shall be inclusive of all the applicable taxes, duties and levies and shall be FOR at site.
- 10. The prices submitted by a bidder during the auction event shall be binding on the bidder.
- 11. No requests for time extension of the auction event shall be considered by RECPDCL.
- 12. The original price bids of the bidders shall be reduced on pro-rata basis against each line item based on the final all inclusive prices offered during conclusion of the auction event for arriving at Contract amount.

In order to achieve these goals, RECPDCL and the above named Bidder enter into this agreement called 'Integrity Pact' which will form a part of the bid.

It is hereby agreed by and between the parties as under:

Section I - Commitments of RECPDCL

- (1) RECPDCL commits itself to take all measures necessary to prevent corruption and to observe the following principles :
 - a) No employee of RECPDCL, personally or through family members, will in connection with the tender, or the execution of the contract, demand, take a promise for or accept, for him/herself or third person, any material or other benefit which he/she is not legally entitled to.
 - b) RECPDCL will, during the tender process treat all Bidder(s) with equity and fairness. RECPDCL will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.
 - (c) RECPDCL will exclude from evaluation of Bids its such employee(s) who has any personnel interest in the Companies/Agencies participating in the Bidding/Tendering process
- (2) If Chairman RECPDCL obtains information on the conduct of any Employee of RECPDCL which is a criminal offence under the relevant Anti-Corruption Laws of India, or if there be a substantive suspicion in this regard, he will inform its Chief Vigilance Officer and in addition can initiate disciplinary actions under its Rules.

Section II - Commitments of the Bidder

- a) The Bidder will not, directly or through any other person or firm, offer, promise or give to RECPDCL, or to any of RECPDCL's employees involved in the tender process or the execution of the contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange an advantage during the tender process or the execution of the contract.
- b) The Bidder will not enter into any illegal agreement or understanding, whether formal or informal with other Bidders. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or actions to restrict competitiveness or to introduce cartelization in the bidding process.
- c) The Bidder will not commit any criminal offence under the relevant Anti-corruption Laws of India; further, the Bidder will not use for illegitimate purposes or for purposes of

restrictive competition or personal gain, or pass on to others, any information provided by RECPDCL as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.

- d) The Bidder of foreign origin shall disclose the name and address of the Agents/representatives in India, if any, involved directly or indirectly in the Bidding. Similarly, the Bidder of Indian Nationality shall furnish the name and address of the foreign principals, if any, involved directly or indirectly in the Bidding.
- e) The Bidder will, when presenting his bid, disclose any and all payments he has made, or committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract and/or with the execution of the contract.
- f) The Bidder will not misrepresent facts or furnish false/ forged documents/ information in order to influence the bidding process or the execution of the contract to the detriment of RECPDCL.
- (2) The Bidder will not instigate third persons to commit offences outlined above or be an accessory to such offences.

Section III- Disqualification from tender process and exclusion from future Contracts

- (1) If the Bidder, before contract award, has committed a serious transgression through a violation of Section II or in any other form such as to put his reliability or credibility as Bidder into question, RECPDCL may disqualify the Bidder from the tender process or terminate the contract, if already signed, for such reason.
- (2) If the Bidder has committed a serious transgression through a violation of Section II such as to put his reliability or credibility into question, RECPDCL may after following due procedures also exclude the Bidder from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressors within the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 12 months and maximum of 3 years.
 - (3) If the Bidder can prove that he has restored/recouped the damage caused by him and has installed a suitable corruption prevention system, RECPDCL may revoke the exclusion prematurely.

Section IV - Liability for violation of Integrity Pact

- (1) If RECPDCL has disqualified the Bidder from the tender process prior to the award under Section III, RECPDCL may forfeit the Bid Guarantee under the Bid.
- (2) If RECPDCL has terminated the contract under Section III, RECPDCL may forfeit the Contract Performance Guarantee of this contract besides resorting to other remedies under the contract.

Section V- Previous Transgression

(1) The Bidder shall declare in his Bid that no previous transgressions occurred in the last 3 years with any other Public Sector Undertaking or Government Department that could justify his exclusion from the tender process.

(3) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

Section VI - Equal treatment to all Bidders

- (1) RECPDCL will enter into agreements with identical conditions as this one with all Bidders.
- (2) RECPDCL will disqualify from the tender process any bidder who does not sign this Pact or violate its provisions.

Section VII - Punitive Action against violating Bidders / Contractors

If RECPDCL obtains knowledge of conduct of a Bidder or a Contractor or his subcontractor or of an employee or a representative or an associate of a Bidder or Contractor or his Subcontractor which constitutes corruption, or if RECPDCL has substantive suspicion in this regard, RECPDCL will inform the Chief Vigilance Officer (CVO)/Competent authority.

Section VIII - Pact Duration

This Pact begins when both parties have legally signed it. It expires for the Contractor after the closure of the contract and for all other Bidder's six month after the contract has been awarded.

Section IX - Other Provisions

(1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the establishment of RECPDCL. The Arbitration clause provided in the main tender document / contract shall not be applicable for any issue / dispute arising under Integrity Pact.
