SECTION-II

PREFACE

Goa Electricity Department (GED) has recently awarded IT Implementation Works under Part-A of R-APDRP Scheme to M/s REC Power Distribution Company Limited (RECPDCL) with Tata Power Delhi Distribution Limited as its Technology Partner.

The Scope of Services includes Preparation of Base-line Data System for the project area covering Consumer Indexing, GIS Mapping, Automatic Metering (AMR) on Distribution Transformers and Feeders, and Automatic Data Logging for all Distribution Transformers & Feeders and SCADA / DMS system for big cities only. It would include Asset Mapping of the entire distribution network at and below the 11kV transformers and include the Distribution Transformers and Feeders, Low Tension lines, poles and other distribution network equipment. It will also include adoption of IT applications for meter reading, billing & collection; energy accounting & auditing; MIS; redressal of consumer grievances and establishment of IT enabled consumer service centers etc.

In addition to the Towns and Cities with a population of more than 30,000 (10,000 in case of Special Category States) as per population data of 2001 Census in Goa, the certain high-load density rural areas with significant loads, works of separation of agricultural feeders from domestic and industrial ones, and of High Voltage Distribution System (11kV) will also be taken up in R-APDRP Part-A scheme and accordingly four towns have been identified to be covered under the scheme as per the details mentioned in Table 1.

Goa, a tiny emerald land on the west coast of India, the 25th State in the Union of States of India, was liberated from Portuguese rule in 1961. It was part of Union territory of Goa, Daman & Diu till 30 May 1987 when it was carved out to form a separate State. Goa is India's smallest state in terms of area and the fourth smallest in terms of population. Located on the west coast of India in the region known as the Konkan, it is bounded by the state of Maharashtra to the north and by Karnataka to the east and south, while the Arabian Sea forms its western coast.

Panaji (also referred to as Panjim) is the state's capital. Vasco da Gama is the largest city. The historic city of Margao still exhibits the influence of Portuguese culture and renowned for its beaches, places of worship and world heritage architecture, Goa is visited by hundreds of thousands of international and domestic tourists each year. It also has rich flora and fauna, owing to its location on the Western Ghats range, which is classified as a biodiversity hotspot.

Goa covers an area of 3702 square kilometers and comprises two Revenue district viz North Goa and South Goa. Boundaries of Goa State are defined in the North Terekhol River which separates it from Maharashtra, in the East and South by Karnataka State and West by Arabian Sea. Goa lies in Western Coast of India and is 594 Kms (by road) away from Mumbai city.

Goa, for the purpose of revenue administration is divided into district viz. North and South Goa with headquarters at Panaji and Margao respectively. The entire State comprises 11 talukas. For the purpose of implementation of development programmes the State is divided into 12 community development blocks. As per 2001 census, the population of the State is 13,42,998. A very striking feature of Goa is the harmonious relationship among various religious communities, who have lived together peacefully for generations. Though a late entrant to the planning process, Goa has emerged as one of the most developed States in India and even achieved the ranking of one of the best states in India with regards to investment environment and infrastructure.

SECTION-IV SCOPE OF WORK & SERVICE LEVEL AGREEMENT

1. Detailed Scope of Work

1. Supply, installation, commissioning of Touch Screen Kiosk, Cash/Cheque Collection Kiosk, related equipment and Software at locations / offices specified in the Release Order.
2. All supplied items must conform to the detailed technical specifications mentioned in this tender document.
3. Packaging and transportation from the manufacturer's work to the site including port and customs clearance will be borne by the bidder.
4. Receipt, storage, preservation and conservation of equipment at the site.
5. Insurance of all equipment from manufacturer's site till installation, commissioning, handing over and user acceptance will be borne by the bidder.
6. Maintain the mandatory and recommended spares during warranty and AMC period and provide the list of the same.
7. Install the equipment, obtain user acceptance and submit a copy of user acceptance to designated authority.
8. Whenever a material or article is specified or described by the name of a particular brand, manufacturer or trade mark, the specific item shall be understood as establishing type, function and quality desired. Products of other manufacturers may also be considered, provided sufficient information with necessary certificates and documents are furnished so as to enable RECPDCL to determine that the products are equivalent to those named. The Decision of RECPDCL shall be final and binding on the bidder in this regard. In case bidder proposes the products of other manufacturer, necessary certificates and documents shall be submitted along with the bid.
9. The bidder shall provide 3 years onsite warranty and 2 years Annual Maintenance Contract (AMC) of all supplied, installed and commissioned equipment as per Service Level Agreement (SLA).
10. Provide ongoing product information and documentation such as User manuals, System administrator manuals, Technical manuals, Installation guides etc. as applicable.
11. The Bidder shall be responsible for providing all material, equipment and services specified or otherwise, which are required to fulfil the intent of ensuring operability, maintainability and the reliability of the complete work covered under this specification.
12. It is not the intent to specify all aspects of design and installation of associated systems mentioned herein. The systems, sub-systems and equipment/devices shall conform in all respect to high standards of engineering, design and workmanship, and shall be capable of performing continuous commercial operation.
13. The vendor will arrange for an engineer for supporting / repairing / replacing, Touch Screen Kiosk, Cash/Cheque Collection Kiosk and make sure the response time is such that restoration is achieved in prescribed time. The engineer requires to visit different offices for supporting the equipment.
14. Preventive Maintenance: Vendor will carry out required Preventive Maintenance as per the schedule mentioned in SLA, which comes in the scope of this agreement. The downtime

required for preventive maintenance will be communicated to concerned office by the vendor in advance.

15. The bidder shall adhere to all the terms and conditions mentioned in the service level agreement (SLA).

16. The service during warranty on equipment will be on-site.

2.2 Cash/Cash Collection Kiosk.

Bill Payment Kiosk with dual Core or higher processor, 2 GHz or above internal clock speed, 2 GB DDR2 RAM or more, minimum 160 GB HDD, CD ROM Drive, Latest version of OS type: Windows/linux with x-window/Mac OS and other specifications requirements as per Section-18above (i.e. Work Station PC Specification), 15" TFT capacitive Touch Screen Monitor, Thermal Printer, in-built Currency Validator as per RBI guidelines (To accept notes in the denomination of Rs 500, 100, 50, 10, 5 and coins Rs 5, 1) Magnetic Ink Character Reader, Laser Printer, Speakers, Surveillance Camera, Suitable Modem, UPS (15 Min Backup and to be provided at the bottom for stability) & With Application Software. The collection information shall be updated immediately to master billing database.

- a. The Machine should be able to accept both MICR and NON MICR Cheque through Motorized MICR Cheque reader with printing on back side, minimum 30 character.
- b. It should be supporting an automated operation with the voice guidance.
- c. The operation of cheque deposit and printing of duplicate bill has to be interactive and user friendly.
- d. The machine should have redundant power supply provision. There should not be any information loss in case of power failure.
- e. Customer waiting time should be minimum possible.

- f. The errors should be less than + 1% within the active area.
- g. Touch life should be greater than 200 million touches in any one location.
- h. Machine should support configurable receipt format. The Thermal receipt Printer shall be 40 Col. with auto cutter and with print speed 180mm/sec.
- i. The laser printer shall be 80 columns for duplicate bill printing.
- j. The bar code laser scanner shall be provided which should be able to read Barcodes for length up to 200mm.
- k. The kiosk should have cooling fan with exhaust vent at the top, lockable doors with three sets of keys, sliding drawers, power distribution, adequate earthing as per Electricity act and sufficient space for all the components to fit in.
- l. Dirt, grease, smoke, water droplets or other surface contaminants should not affect the touch screen.
- m. Touch screen should be resistant to corrosives.
- n. Touch screen should not be scratched using any stylus with Mohs' rating less than 6.5.
- o. The application software should have no exit buttons and provide no access to system files on touch screen. The application can be closed only through the keyboard.
- p. The monitor should be fitted at an angle of 30o from vertical to have viewing angle of less than 70o and at a height of minimum 1200 mm from ground.
- q. In case of receipt of fake currency, the system should not return the fake currency, immediately take a snapshot of the user through in-built surveillance camera and keep record such as account number, date, time etc and generate the exception reports at the end of the day or as and when required as per RBI guidelines.
- r. The housing should be High Grade steel.
- s. The in-built Cheque deposit box shall have capacity to store 2000 Cheque.
- t. The depository safe should be made from thick steel with appropriate lock.
- u. System to be provided with UPS system, capacity of which should be indicated by bidder

2.3 General specifications for Touch Screen and Cash/ Cheque Collection Kiosk Cabinet:

Since the kiosk cabinet should have an aesthetic and attractive look with following features:

- a) The Kiosk cabinet should have a fan for proper cooling.
- b) The Kiosk cabinet should have a backside door for easy accessibility into kiosk.
- c) The Kiosk cabinet should have the back door locking system.
- d) The Kiosk cabinet should be rugged to stand against all weather conditions.
- e) The Kiosk cabinet should look slim and sleek.
- f) The kiosk cabinet should occupy less space/ small foot print area.
- g) The Kiosk cabinet should have speakers with multimedia capability.
- h) The bidder is required to give the detailed dimensions of the kiosk along with the bid
- i) The kiosk cabinet should be of steel having compartments for CPU, Monitor, Keyboard etc.

6. In case of intranet medium, RECPDCL shall provide the infrastructure to bidders. Further, RECPDCL has sole discretion to extend or restart the auction event in case of any glitches in infrastructure observed which has restricted the bidders to submit the bids to ensure fair & transparent competitive bidding. In case an auction event is restarted, the best bid as already available in the system shall become the basis for determining start price of the new auction.
7. In case the bidder fails to participate in the auction event due any reason whatsoever, it shall be presumed that the bidder has no further discounts to offer and the initial bid as submitted by the bidder as a part of the tender shall be considered as the bidder's final no regret offer. Any offline price bids received from a bidder in lieu of non-participation in the auction event shall be out rightly rejected by RECPDCL.
8. The bidder shall be prepared with competitive price quotes on the day of the bidding event.
9. The prices as quoted by the bidder during the auction event shall be inclusive of all the applicable taxes, duties and levies and shall be FOR at site.
10. The prices submitted by a bidder during the auction event shall be binding on the bidder.
11. No requests for time extension of the auction event shall be considered by RECPDCL.
12. The original price bids of the bidders shall be reduced on pro-rata basis against each line item based on the final all inclusive prices offered during conclusion of the auction event for arriving at Contract amount.
