With reference to the above-referred tender invited through e-Tendering mode for “**CONSTRUCTION OF 11KV LINE INSTALLATION/AUGMENTATION OF DISTRIBUTION TRANSFORMERS ALONG WITH OTHER ASSOCIATED WORKS IN LEH & KARGIL TOWNS ON TURNKEY BASIS UNDER R-APDRP PART-B.**”, RECPDCL will carry out the Reverse Auction as per the Clause no.46(X) of Volume-I Section IV (General Conditions of Contract), among the technically qualified bidders as mentioned below on due date & time as hereunder:

The methodology to calculate item wise minimum rate from the quoted overall rate along with Reserve price, Decrement value, time duration & Incremental time are as follows:

1. Reserve/Ceiling price to be kept for conducting e-reverse auction is Rs. 28,49,09,453.14/-.
2. The overall lowest price quoted by the bidder will be considered as L-1 bidder after completion of reverse auction. Further, the item wise price shall be arrived from the overall lowest quoted price in the same ratio as quoted by the bidders earlier in the financial bids opened on 16.07.2018.
3. Decrement value to be kept for conducting Reverse Auction is Rs. 57,00,000.00/-.
4. The time duration to be kept for conducting Reverse Auction process is from 11.00 AM to 3.00 PM with the incremental time duration of 30 minutes.
