

**NOTIFICATION - for e-REVERSE AUCTION (e-RA)**  
**Arunachal Pradesh Solar Tender (PACKAGE 2 - DDUGJY Scheme)**

With reference to the NIT invited through e-tendering mode for **Design, Engineering, Manufacture, Testing, Supply, Insurance, Transportation, Delivery (FOR basis) of items of Solar Home Lighting Standalone System for electrification of Off-Grid villages in Arunachal Pradesh under Deen Dayal Upadhyaya Gram Jyoti Yojana (DDUGJY) Scheme (Package 2)**, RECPDCL will carry out the Reverse Auction among following technically qualified bidders in Package 2 of the tender as per Cl. No.2 (g) under Section-7 / Cl. No.10 under Section-6 of the tender document.

EMD submitted against the NIT by the bidders is valid and RECPDCL will consider the same for the purpose of Reverse Auction. All other terms and conditions will remain the same.

The methodology to conduct Reverse Auction along with Reverse Auction ceiling Price, Decrement value, time duration & Incremental time are as follows:

1. Reverse Auction ceiling price for entire scope of Package 2 is fixed at "**Rs. 16,27,74,470.44/-**"
2. The overall lowest price quoted by the bidder will be considered as L-1 bidder after completion e-reverse auction. Further, the item wise prices shall be arrived from the overall lowest quoted price in the same ratio/proportion as quoted by the bidders earlier in the financial bids opened on 07.09.2018.
3. Decrement value to be kept for conducting Reverse Auction is Rs. 10,00,000/-(Rupees Ten Lakhs Only).
4. The time duration to be kept for conducting Reverse Auction process is from 11:00 am to 3.00 pm with the incremental time duration of 30 minutes.
