Based on the credentials and performance in the personal interview the candidates will be selected and the offer of engagement shall be issued to the suitable candidates in the order of merit and based on the number of vacancies and will be subject to verification of antecedents.
3. RECPDCL may adopt higher criteria in case of receipt of more number of applicants meeting eligibility criteria.

GENERAL INFORMATION

1. **The appointment is purely on Fixed Tenure Basis and it is not against any permanent vacancy. This placement will not entitle any candidate to claim for regular/ permanent employment in RECPDCL and RECL.**
2. Only Indian Nationals are eligible to apply.
3. The candidate shall be selected on the basis of performance in walk-in interview only and the offer of engagement shall be issued to the selected candidates in the order of merit and based on the number of vacancies.
