RELAXATIONS/ CONCESSIONS:

- Relaxation of age in respect of SC/ST/OBC- NCL/PWD and Ex-Servicemen/ J&K domicile category will be
 as per Govt. of India guidelines. Also, the reserved post mentioned in detailed advertisement is for OBCNCL only.
- 2. The minimum qualification requirement in terms of percentage of marks/division has been relaxed to pass marks/percentage for the Candidates belonging to SC, ST and PWD category.

MEDICAL FITNESS:
