SECTION-III

DETAILED SCOPE OF WORK

The proposed scope of work:

- a) Review of the financial statements, tax audit report and other documents and Assisting and Vetting of Corporate Income Tax Returns. Advising about impact assessment of ICDS and necessary adjustment about Ind-AS in accounts for tax computation point of view.
- b) Assistance in all direct taxes compliances including assessment / reassessment proceedings/ demands/ rectification applications/ review of orders including any penalty proceedings as applicable initiated by assessing authorities including drafting/ filing of replies, stay of demand and submissions and representation, pursuing, assisting and coordinating with Income Tax Authorities related to the matters of RECPDCL (REC Power Development and Consultancy Limited) and RECTPCL (REC Transmission Projects Company Limited) for getting released all refunds/settle demands and review of the assessment order passed by AO and determine in conjunction with RECPDCL and RECTPCL the need, if any to challenge the order before higher forums.
- c) Detailed examination of various receipts and expenses of RECPDCL and crystallizing the specific positions to be adopted in respect of such receipts. Advising on accounting issues, suggesting improvement in systems, procedures and accounting records with respect to Taxation and compliance with Accounting Standards etc. Assisting RECPDCL in tax planning, assessing its tax positions and advising on various economically efficient options available as and when required including advance tax planning.
- d) Rendering expert opinion on call/in writing as and when required by RECPDCL for all Direct taxation issues including TDS, deferred tax etc. Updating RECPDCL on all day to day changes in relevant taxation laws and suggesting measures for effective adaptation of changes in RECPDCL, wherever required.
- e) To provide regular updates related to Direct Taxation to RECPDCL.

2. **Duration of Contract:**

The duration of contract shall be One Year effective from the date of placement of LOA. The contract shall be extendable for further two years based on satisfactory performance. The contract may be terminated by REC PDCL by giving one month notice without prejudice to the rights and obligations of the parties up to the date of notice of termination by REC PDCL.

3. Confidentiality:

During the tenure of the contract and at any time thereafter Direct tax advisor keep all information relating to the work in full confidence and shall not, unless so authorized in writing by RECPDCL, divulge or grant access to any information about the work or its result and shall prevent anyone becoming acquainted with either through Direct tax advisor or its personnel or agents.

4. Subletting:

The Firm appointed as Direct Tax advisor shall not outsource the work to any other associate/franchisee/third party under any circumstances.

SECTION - IV

Terms & Conditions

- 1. The bidder must be a Chartered Firm having vast experience in Corporate Direct Taxation and handle the regular matters related to assessment, appeal, demand and refund from income tax authorities.
- 2. Documentary evidence of firm's GST Registration shall be furnished. Bids not accompanied by the requisite documentary proofs shall be rejected.
- 3. Bids shall remain valid for 90 days from the date of Bid Opening. Any Bid valid for a shorter period than the period specified shall be rejected as nonresponsive.
- 4. Last date & Time for receipt of Bids: The last date for receipt of Bids is **01.12.2021** till **14:00** Hrs. Bids will be opened on the same day at **16:00** Hrs.
- Submission of Bids: The completed bids may be submitted in online mode only as specified in Section-II of the NIT. Bids submitted through any other mode will not be accepted.
- 6. Bidders shall well acquaint themselves from tender wizard website and RECPDCL will not be responsible for any delay on account of website related issues on last date of bid submission. Submission a Late Bid Any delay, including postal delay, in the receipt of bid would be treated late submission of bid and shall be rejected.
- Bids handed over at the Reception Counter or any other counter or room or to any person, other than the authorized person of RECPDCL, shall not be considered.
- 8. Language of Bids: The Bids prepared by the Bidder and documents relating to the bids exchanged by the Bidder and RECPDCL, shall be written in English language, provided that any printed literature furnished by the Bidder may be written in another language so long as the same is accompanied by an Hindi /English translation in which case, for purposes of interpretation of the bid, the English version shall govern.

9. Bid Prices

- b) All taxes, duties, levies applicable etc. shall be clearly indicated.
- c) Prices quoted must be final and shall remain constant throughout the period of validity of bid and shall not be subject to any upward modifications, whatsoever.
- d) Bidders shall indicate their rates in clear/visible figures as well as in words and shall not alter/overwrite/make cutting in the quotation.
- e) Conditional Financial Proposals will be rejected out rightly. Please note that the non-understanding of the scope of work at any stage will
