## **SECTION– 4**

### **DETAILED SCOPE OF WORK**

Broad scope of work for the given task but not limited to the following:

Work involves the following major activities:

#### **1. Preprtion of BoQ, Estimation of Project Cost and Financial Analysis**

- Adequate quantities of material (AC & DC capacity of solar plant)
- Realistically estimated pricing of major materials (such as module, inverter, module mounting structure, cables, transformer, land and associated cost, etc.)
- Estimation of transmission line with suitable voltage level, Auxiliary consumption, Transmission line losses, Bay extension, Route Survey. For estimation of cost towards power evacuation and land, Site visit also to be carried out.
- List of clearances/approval required.
- Estimation of O&M cost (spare parts inventory, replacement schedules and associated cost, Insurance cost, yearly lease amount and escalation etc.)
- Various options and scenarios analysis (e.g. CUF, Degradation, Debt: equity Ratio, Interest Rate, Return on equity, Discount Rate, Tax scenario, etc.)
- Energy Yield Estimation and Financial Analysis (LCOE and tariff analysis).
- Variation in quantities and pricing if the allotted capacity is lower than bidding capacities in the multiples of 50MW i.e. 100MW & 150MW etc.

#### **2. e-RA support:**

- Live support during bidding.

**Note:** Tentative bidding capacity is 200MW. However, the capacity may change at the time of bidding.

## SECTION- 5

### GENERAL CONDITIONS OF TENDER

1. Each bidder should submit **ONLY SINGLE** bid. Submission or participation in more than one bid will cause disqualification of all the proposals submitted by the bidder.
  2. The bidder shall ensure that deputed personnel are trained and experienced for jobs as defined in scope of work for ensuring the high quality and correctness of jobs so that job is carried out in a highly professional, safe, and sound managerial manner.
  3. RECPDCL reserves the right to accept or reject any or all bid requests without assigning any reason. RECPDCL reserves the right to waive off any shortfalls; accept the whole, accept part of or reject any or all responses to this tender.
  4. RECPDCL reserves the right to cancel the tender at any stage and call for fresh tender.
  5. RECPDCL reserves the right to modify, expand, restrict, scrap, re-float the tender without assigning any reason for the same.
